## CHAIRMAN'S 2021 REPORT

### Michael McKenna

I am pleased to present this report to members and other interested and related parties on the 2021 calendar year for the State Association of Tenpin Bowling Association of Queensland Incorporated.



As Chairman I would like to acknowledge the **TBAQ Board members**, who volunteered their time in 2021 - Morty Douglass and Nathan Stein (VP South), Frank Nucifora (VP North), Carmel Raju (Treasurer), Brian Bates (proprietor representative), Sharon Stephenson (Secretary). Our Committee leaders, NQ Junior committee Tyson Jones, SQ Junior Committee Nathan Stein, Adult Committee Morty Douglass, Youth Coordinator Don Lindsay, NQ Adult Committee Bob Doyle, State Disabilities Beth Boyd, and their teams for their dedication to TBAQ and the sport.

**TBAQ acknowledges the support the State Government provides**, as the single largest financial contributor to TBAQ. TBAQ have delivered sport services aligned to the Active Queensland 10 year Strategy growing participation through sport services delivered in a large state. Without their support, the Board's task of maintaining and growing an extensive list of sport services of benefit to the community would be a challenge.

TBAQ also acknowledge those efforts of our local associations, committees, and State sport development team at the TBAQ office. We acknowledge sport registered venues supporting sport pathways and Tenpin Bowling Australia (TBA), our National Supporting Organisation.

**TBAQ have delivered, best practice delivery models** to meet current needs of the Sport of Tenpin and the Community through the use of technology to meet the challenges of distance both economically and operationally. TBAQ launching the TBAQAPP in 2021 and planning to expand our online digital resources into 2022.

**Thanks to the TBAQ CEO and staff and our valued volunteers** driving outcomes, assisting the growth and development of our sport in Queensland. We have had again a remarkable year. TBAQ managed the supply and maintenance of \$300,000 of modified tenpin bowling equipment to schools, universities and communities during 2021 with demand growing each year for our, all abilities, all gender, fun activity available at no cost to schools and community groups, hospital rehab units and also in use in afterschool and holiday care programs.

**Commercial centres partnerships** were integral in supporting the delivery and sponsorship of 20% of our School Roll 'n Strike resources (modified tenpin lanes) 80% provided by positioning further sponsorships and in partnership with Tenpin Bowling Australia supporting Sporting Schools programs in Qld. Our Roll 'n Strike program in schools reaching just over 77,000 school children in Qld. Conversion rates from community to the sport venue is desirable to ensure a lifetime habit of activity and participation keeping Queenslanders active and healthy. TBAQ distribute invitations and offers from local centres to schools and have new digital competitions available to further entice more of the 77K children in Roll 'n Strike programs to participate in sport pathways at local venues.

**2021 Operational Staff:** Gail Torrens (CEO and Coaching Director), Sharon Stephenson (Office Manager and State Accounts), Dylan Stubbs full time Development Officer, Zac Mabb casual development officer, Robert Mitchell part time Development officer.

Gail is the Chairperson of the QSport Indoor Sports Group (22 Qld Indoor Sports). Our Covid Indoor Sport Industry Plan provided to all commercial centres in Qld is the result of QSports activities in partnership with the Queensland Government. We were fortunate to get our centres back in operation as early as possible thanks to the delivery of plans and guides constructed by Gail for Indoor Sport in Qld through QSport. Qld proprietors quick to take on the plan to protect customers, providing a covid safe environment.

**Volunteer committees and coaches** provide pathway events, Junior and Youth Development camps, 'learn to bowl, 'coach supported state- wide leagues', research and development, coach, officials and athlete pathways, coach and official recruitment.

TBAQ was active in the support of community organisations operating in sports halls, multi-sport expos, and support for people with a disability. Plans for the expansion of these services, early learning programs (Tenpin Tots) and support targeting 45-65 year olds and retirement homes are ongoing.

Queensland (TBAQ) was the first State in the sport of Tenpin Bowling to initiate the 'in-school' development program Roll 'n Strike. Expanding support services to Universities increases our reach in Queensland. **TBAQ have on-line teacher development program** as an example of effective best practice option to teachers prior to their placement in schools. TBAQ provide Universities and Schools with the tools to teach. The Roll 'n Strike program keeping all students (up to 36 in a class) on task at all times. The Roll 'n Strike program of Tenpin Bowling is used in Universities as an effective teaching tool in the Bachelor of Education HPE pedagogy unit at Southern Cross University in past years and offered to 6 Universities in Qld.

**Acknowledgment of our partnership with State Government** is within our video education support material and all of our communications of sport services. TBAQ have updated our teacher resources, aligning with current Australian curricula requirements with a new look manual utilising curriculum specialist to further advance our resources, available on line in 2022.

TBAQ connect through **Qld RecCONNECT** to offer sport services to an inclusive audience. Resources such as the Auslan video to better orientate persons with a hearing impairment to the sport and recreation of tenpin are available. TBAQ support all services aligned with Bowl Ability the National Inclusive program. Tenpin Bowling is the number one activity choice providing the physical and emotional success of participation.

TBAQ has a base of **25 sport registered Bowling Centres** state-wide in 2021. Some centres represented by both a junior and adult associations/clubs. TBAQ has **30 Associations** existing in Qld. Qld TBA Sport membership just over 7000 and recreational bowlers in 2021 numbering over 300,000.

We have **6 Volunteer committees** who deliver our State and Zone Championships and Events. **Our committees are in charge of pathways of state representative teams** for all categories of bowler, and 2 event specific committees who manage state driven events for juniors (QJC), for juniors 21 years and under and another division 18 and under, and the PPMG committee for seniors over 35 years of age. TBAQ provided governance resources and guides at no cost to Associations in 2021 through an external organization Community Sport utilizing "Club Spot". Ensuring up to date governance guides, templates and assistance is provided, and have entered into an agreement to continue this support into the future.

2021 a stellar year for Queensland dominating National medal tallies in Team events, Junior (triple Gold – Girls, Boys and overall) Adult (Mens Gold medal) Youth (Girls Gold medal) and numerous individual podium finishes across singles, doubles and Masters events.

**The State Based Training Squad** is the pathway to National teams along with ranked events, for Qld Tenpin Bowling Talent ID processes. Covid caused some events to be cancelled in 2021 however many programs still went ahead. The State Training Squad is accessible to all categories of bowler including, Junior, Youth, Adult, Senior and Bowlers with a disability. The State based training Squad program for athletes is also a training ground for our coaches. Local coaches passing this knowledge through TBAQ coach education workshops accessed at regional and rural areas. Gail has launched a newly updated **12 frame program** to provide training to enhance athletes tournament success and it has been accepted well details on our education and training calendar of upcoming dates.



TBAQ provided **Coach Workshops** to upskill and support local coaches to deliver up to date material to athletes. **Coach Developers** (4 to date situated in Rockhampton, Bundaberg, Townsville, Brisbane, Cairns) with further networks to be built over the next 5 years to support and expand our numbers of coaches.

**Junior pathway** process allows Queensland juniors to fast track to national levels through State and international experience opportunities boosting results at national levels with more of our junior and youth athletes gaining places in Australian teams through National tournament rankings and selection to compete overseas.

TBAQ introduce World Champion Professional bowlers to join our high-performance program including activity in our Junior and Youth development Program and State Training Squad promotions in addition to our regular clinics and camps available in North Queensland and South Queensland. Jason Belmonte (World ranked Number 1) recently providing video to our juniors at training camps and to ranked Qld tournaments such as the Qld Junior Cup in 2021. This exposure encouraging juniors from across Australia has proven to be extremely popular and successful.

**The expansion of our sport services** and the sheer size of our popular in school program necessitated us to continually rebuild the functions of our website. Functions such as ongoing library of reports on events held locally and state -wide, location finders for local bowling venues, community services are enhanced through automated school booking of free resources provided to schools via our website and education and training videos available online for teachers. We will constantly evolve our IT to meet our needs.

TBAQ are in the process of streamlining our reporting processes and rebuilding volunteer numbers across Queensland. The transient nature of the population in some regions of Queensland poses a constant challenge for us as a state sporting organization. Our sport boasts 23 venues in all regions of Qld with our school program covering more of the State, we have been successful delivering consistent services where we are short of volunteers by providing part time development officers to deliver those services.

*TBAQ through responsible governance, financial management and sport service delivery have built a stable and well-run State Level Sporting Organisation and we look forward to another exciting and we are sure challenging year, delivering sport services to all regions of Queensland.*

We are grateful for the support of the Queensland tenpin community, stakeholders and volunteers we work with, and the financial support of the State Government in Queensland.

## Tenpin Bowling Association of Queensland Inc.

### Notes to the Financial Statements

For the Year Ended 31 December 2021

The financial statements cover Tenpin Bowling Association of Queensland Inc. as an individual entity. Tenpin Bowling Association of Queensland Inc. is a not-for-profit Association incorporated in Queensland under the *Associations Incorporation Act (QLD) 1981 (as amended by the Associations Incorporation and Other Legislation Amendment Act (QLD) 2007)* (the Act).

The functional and presentation currency of Tenpin Bowling Association of Queensland Inc. is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated.

#### 1 Basis of Preparation

In the opinion of the Committee of Management, the Association is not a reporting entity since there are unlikely to exist users of the financial statements who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. These special purpose financial statements have been prepared to meet the reporting requirements of the Act.

The material accounting policies adopted in the special purpose financial statements are set out in note 2 and indicate how the recognition and measurement requirements in Australian Accounting Standards have not been complied with.

#### 2 Summary of Significant Accounting Policies

##### (a) Income Tax

The Association is exempt from income tax under Division 50 of the *Income Tax Assessment Act 1997*.

##### (b) Revenue and other income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Association and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

##### Grant revenue

Grant revenue is recognised in the statement of profit or loss when the entity obtains control of the grant, it is probable that the economic benefits gained from the grant will flow to the entity and the amount of the grant can be measured reliably.

When grant revenue is received whereby the entity incurs an obligation to deliver economic value directly back to the contributor, this is considered a reciprocal transaction and the grant revenue is recognised in the statement of assets and liabilities as a liability until the service has been delivered to the contributor, otherwise the grant is recognised as income on receipt.

Tenpin Bowling Association of Queensland Inc. receives non-reciprocal contributions of assets from the government and other parties for zero or a nominal value. These assets are recognised at fair value on the date of acquisition in the statement of assets and liabilities, with a corresponding amount of income recognised in the statement of profit or loss.

All grant income has been deferred upon receipt and not recognised as revenue until the related expenses are incurred, without assessing whether enforceable performance obligations exist. This does not comply with *AASB 15 Revenue from Contracts with Customers* or *AASB 1058 Income of Not-for-Profit Entities*.

#### 2 Summary of Significant Accounting Policies

(b) **Revenue and other income**

**Interest revenue**

Interest is recognised using the effective interest method.

**Other income**

Other income is recognised on an accruals basis when the Association is entitled to it.

(c) **Goods and services tax (GST)**

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payable are stated inclusive of GST.

Cash flows in the statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

(d) **Inventories**

Inventories are measured at the lower of cost and net realisable value. Cost of inventory is determined using the first-in-first-out basis and is net of any rebates and discounts received. Net realisable value is estimated using the most reliable evidence available at the reporting date and inventory is written down through an obsolescence provision if necessary.

(e) **Cash and cash equivalents**

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

(f) **Employee benefits**

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

Long-term provisions recognised for long service leave has been measured on the undiscounted basis. The probability that an employee may satisfy vesting requirements has not been taken into account. This treatment of long service leave entitlements does not comply with *AASB 119 Employee Benefits*.

#### 2 Summary of Significant Accounting Policies

##### (g) Leases

Operating leases are recognised through the profit and loss when payment is made.

The method of not recognising operating leases on the statement of financial position does not comply with *AASB 16 Leases*.

#### 3 Critical Accounting Estimates and Judgments

The directors make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.

The significant estimates and judgements made have been described below.

##### Key estimates - receivables

The receivables at reporting date have been reviewed to determine whether there is any objective evidence that any of the receivables are impaired. An impairment provision is included for any receivable where the entire balance is not considered collectible. The impairment provision is based on the best information at the reporting date.

Subsequent to year end it was established that a \$150,000 term deposit created in November 2021 was fraudulent. The funds were transferred to an external party under the assumption that the funds were being invested into a term deposit with Barclays bank. In February 2022 it was determined that individuals were impersonating Barclays bank and the funds were actually transferred to an unknown party. The police have been notified of this situation along with the insurance provider of TPBQ, management have determined that the likelihood of recoupment of these funds is remote and have therefore expensed the full amount in the 2021 year.

Except for the above, no other matters or circumstances have arisen since the end of the financial year which significantly affected or could significantly affect the operations of the Association, the results of those operations or the state of affairs of the Association in future financial years.

As part of an audit in accordance with Australian Auditing Standards, we exercise professional judgement and maintain professional scepticism throughout the audit. We also:



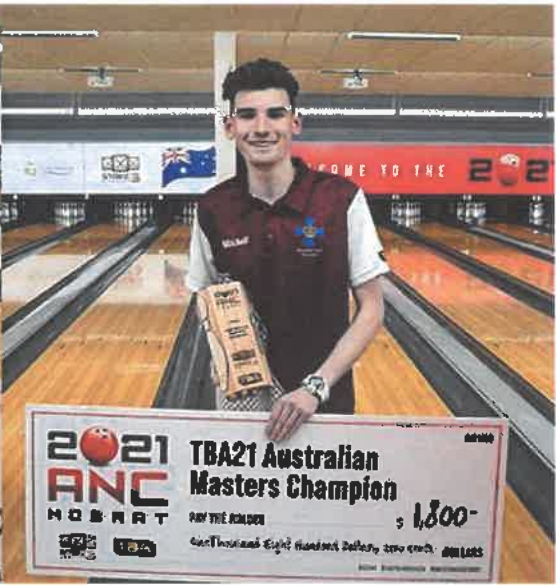

The last 12 months have certainly been challenging; however it is good to see participation back in our sport after the COVID effected years of 2020 and 2021

The 2021 Zone Championships was moved to later in the year and also incorporated President Shield Trails. We had support of approx 80 entrants from across South Queensland and look forward to taking to Zone Championships to Maryborough in October 2022 - the first ever time it will be held from a metro centre.

The 2021 Shield Team attended the 2021 ANC National and it was a terrific feeling to capture triple Gold. Whilst it was partially COVID impacted, 6 states still got to complete (pretty good result in the end to be fair).

The team consisted of Hayden Rowe, Jack Colmer, Connor Renton & Jordan Harrold in the boys and Tahlia Corbett, Jessica Canfield, Katy Melton & Tamika Pettigrew for the girls.

5 all starred - Hayden, Jack, Jordan, Tamika & Katy. Outstanding. Jack Colmer also won the Boys masters, Kayla Piffero picked up silver in the Girls Masters & Katy Melton came second in the inaugural Under 14 Masters, Amazing performances.

It is good to see that Shield will return to the traditional 5 person team, however the overall structure of the ANC concerns us and does not create a pathway for future elite juniors. The Franchise system also needs to be reviewed as it is seeing many parents/athletes look to bypass the state pathway system and take a "cheaper" option. We did propose a structure that gained a support of nearly all of the states, but this was simply rejected or ignored by the tournament promoters. I fear for the future of the National Championships and believe the current formats in killing off the future of our sport - a far cry from where we need it to be as we move towards Brisbane 2032 and a push for Olympic entry.

The QJC simply get stronger and stronger each year and in 2022 we added the a youth division to cater for a number of former juniors. The re-entry format has proven



extremely popular and it resulted in over 80 re-entries alone and an additional \$3k into the prize fund.

Some exciting times lay ahead but there remains a number of areas that we need to refocus and improve if we are to achieve the goal of having an athlete medal at the 2032 Olympics.

I have also stepped back from President role in 2022 with Rob McDonald to re-assume this role.

The 43rd North Queensland Adult Intercity Shield 2022 was held at the NQ Tenpin Atherton Bowling Centre during the period of the May Day weekend 2022. As the Atherton Bowl is only 10 lanes and the tournament has 6 associations with 2 teams in each division competing, the time table was tight.

On Saturday we gathered at 06.00am to commence at 06.30am with the Opening Ceremony, this included the march pass, speeches by the host association, the reading of the bowler's oath as well as one male and one female being selected as the King & Queen to bowl the first ball.

During the opening ceremony there was a special moment when members of the Starkey family, Edmond Starkey (senior), EJ Starkey and Emily Starkey, 3 generations, sang the national anthem without music. The NQAC also held a minute silence in remembrance of John Dunn, John has been a long-time member of the Mackay Association and has participated for over 30 years in the Intercity tournament.

There are 6 Local Associations, Mt Isa, Cairns, Atherton, Townsville, Burdekin, and Mackay, who play in NQ Intercity Shield. This is a 5-person team event, played over 2 rounds, 15 Games, in four divisions consisting of 1 Female team and 1 Male team in the Division One and 1 Female team and 1 Male team in the Division Two. Each team consists of no more than 7 bowlers and the tournament is held over 3 days. There were approx. 140 bowlers plus coaches and managers who attend this tournament. The winner of the Intercity Shield is determined by the highest total number of points received by the 4 divisions from 1 Adult Association/Sub Committee at the conclusion of the tournament.

Low numbers on Scratch ladies available and eligible for presidents shield but lots of younger ones coming through the ranks.

The Biggest disappointment the NQ has had to deal with this year is a loss in our pathways due to strike 3's franchise appointments. We have worked tirelessly for 10 years to have clear pathways for our juniors and their paths to nationals. Local Champs, NQ Champs, Intercity shield, Presidents shield roll offs... and if you miss roll offs, that's a pathway to draft. The appointment of franchise teams has allowed juniors who " couldn't afford to go" to skirt a lot of the pathways and end up in a team. This needs to be addressed or I fear within the near future there will be no need for state associations, as kids and parents will bypass us for what they deem a cheaper option. With no real cohesion, supervision or structure.

We hope this will be amended before roll offs for next years teams.
