

## **Pan Pac Carnival - GUIDELINES COVID CHECKLIST:**

Queensland is open for business, but there are still some things we need to do to keep COVID safe.

Businesses need to follow the Chief Health Officer [public health directions](#) and keep up-to-date with requirements to make your business and customers COVID Safe.

**All businesses which are restricted under the [Restrictions on Businesses, Activities and Undertakings Direction](#) are required to:**

- use the [Check In Qld app](#) to collect contact details from patrons
- encourage staff and customers to observe physical distancing
- regularly clean and disinfect their business premises, particularly surfaces used by customers and other frequently touched surfaces
- ensure handwashing facilities or hand sanitisers are available for use by visitors and workers
- notify visitors, either verbally or through signage, that they should not enter your premises if they are showing any COVID-19 symptoms
- have [COVID Safe management plans](#) (Work Health and Safety) in place which detail how you, your workers and your patrons will stay COVID safe
- operate under a [COVID Safe Checklist for Restricted Businesses](#), which outlines the COVID Safe requirements.

## **Penalties**

Any person found in breach of the Public Health Directions and/or *Public Health Act 2005*, i.e. to whom a Direction/Act applies, without a reasonable excuse, could face a penalty of up to a maximum of 100 [penalty units](#) or 6 months' imprisonment.

On the spot fines can also be issued.

To avoid this, we recommend you **check back** to this site **regularly** for updates to the requirements.

## **Reporting a breach**

Individuals with concerns about whether a business is complying with the Public Health Directions and/or *Public Health Act 2005* can call **134 COVID (13 42 68)**.

# COVID Safe Checklist for **Restricted Businesses** - **Impacted Areas**

From 6:10pm 8 August 2021, any restricted business operating in an [Impacted Area](#) will need to use the [COVID Safe Checklist for Restricted Business – Impacted Areas](#) until the impacted areas are no longer declared.

Businesses should refer to the resources to the right for specific guidance on implementing each element of the Checklist.

Restrictions for businesses operating in an Impacted Area include:

- Indoors:
  - no more than 1 person per 4m<sup>2</sup> in spaces 200m<sup>2</sup> or more, or
  - no more 1 person per 2m<sup>2</sup> in spaces 200m<sup>2</sup> or less, with a total of 50 people, or
  - 50%t seated venue capacity provided patrons are in ticketed and allocated seating
- Outdoors
  - no more 1 person per 2m<sup>2</sup>, or
  - 50% seated venue capacity provided patrons are in ticketed and allocated seating
  - collection of contact tracing information using the [Check In Qld app](#)
  - regular and thorough cleaning
  - availability of hand washing facilities or hand sanitiser
  - operating an area for dancing is not permitted, except for:
    - wedding ceremonies or wedding receptions, limited to a maximum of 20 people
    - dance studios or dance classes, subject to occupant density requirement
    - performers as part of a performance.

# COVID Safe Checklist for **Restricted Businesses - rest of Queensland**

All businesses occurring outside of an Impacted Area or area subject to Lockdown restrictions must operate in accordance with the [COVID Safe Checklist for Restricted Businesses – Rest of Queensland](#).

Restrictions for businesses occurring outside of an Impacted Area or area subject to Lockdown requirements include:

- no more than 1 person per 2m<sup>2</sup>, or
- up to 100% seated venue capacity provided patrons or guests are in ticketed and allocated seating
- collection of contact tracing information using the [Check In Qld app](#)
- regular and thorough cleaning
- availability of hand washing facilities or hand sanitiser.

Restricted businesses must ensure that a signed copy of the Checklist is displayed at the business premises.
